- g. Tasked to create a proposals for the Center by March 15
- h. Hope to have the Center operational in the fall

## Collegiate Learning Assessments

- a. Did not test last fall due to low turnout, concern about the investment the university put into it for the return that we got
- b. We need to do CLA
- c. It gives us comparative data analysis
- d. We will bring the CLA back in the fall
- e. Try to get assistance on this
- f. Looking for better ways to implement so that we get a better return
- g. They have implemented a new process CLA Plus they will be out in April 2013
- h. Curious about the mechanism they have for online learners
- i. Hopefully the new version will address the online learners
- j. Expensive project \$3500 100 freshman students in the fall and 100 senior students in the spring
- k. New CLA looks at all classes
- 1. How to get students to participate will be a struggle
- m. Will be able to do point of entry instead of freshman
- n. We are also going to look at the ETS proficiency profile which looks at some of the same things as CLA critical thinking and reasoning
- o. ETS goes a step further with a math section
- p. In the past invited all freshman to take the exam provided 1000 names and they pulled 200
- q. ETS has more options for testing
  - i. Can be proctored or not
  - ii. Online or paper
- r. Maybe look at all students at least for one cycle if not too expensive
- s. Trying to determine if we want to run both the CLA and ETS
- t. 2 versions
  - i. Writing task 60 minutes
  - ii. Another 25 multiple choice questions
  - iii. Both assess the same thing
- a. Must use something so that we can assess our online students also
